**This Plan Uses the Comprehensive+ Formulary:**

Your plan uses the Comprehensive+ formulary, which means you have coverage for every drug identified by Medicare as a Part D drug, as long as the drug is medically necessary, and the plan rules are followed. **Non-Part D Supplemental Benefit**
